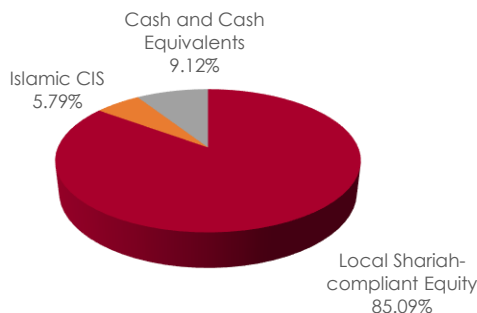

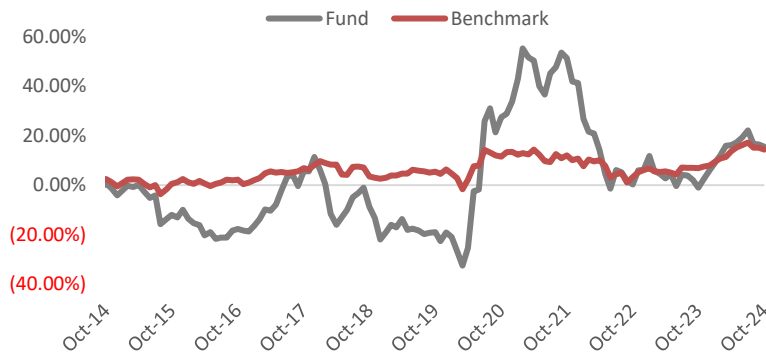
ASSET ALLOCATION

FUND MANAGER'S REVIEW

In October, the Fund posted a return of -0.75%, underperforming its benchmark, which achieved a return of -0.64%. This translated to a slight underperformance of 0.11%, in line with the negative performance of the local equity market.

We anticipate a cautious sentiment in regional markets as investors await economic data from the US and China, particularly in light of the implications of a potential second Trump Presidency. Disappointing economic indicators could adversely affect market sentiment. Domestically, attention may shift toward state budget details, especially Johor and Sarawak's Budget 2025, which is expected to provide a boost to the construction sector.

Meanwhile, we maintain a cautious outlook on the FBMKLCI, with a downside bias in the medium term due to weakening technical indicators. Key support is identified at 1,600 points, while resistance is observed in the 1,630-point range. In this volatile environment, our strategy focuses on high-quality Shariah-compliant stocks, seeking opportunities during market consolidations, and maintaining a long-term perspective to capitalize on undervalued stocks.

Note:

Based on the Fund's portfolio returns as at **10 NOVEMBER 2024**, the Volatility Factor (VF) for this Fund is **14.1** and is classified as "**High**". The VF means there is a possibility for the Fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified Funds. VF is subject to monthly revision and VC will be revised every six months. The Fund's portfolio may have changed since this date and there is no guarantee that the Fund will continue to have the same VF or VC in the future. Presently, only Funds launched in the market for at least 36 months will display the VF and its VC.

Lipper Ratings for Total Return reflect fund historic total return performance relative to peers. Lipper Ratings for Consistent Return reflect fund historical risk-adjusted returns relative to peers. Lipper Ratings for Preservation are relative, rather than absolute.
