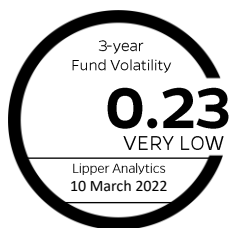

FUND MANAGER'S REVIEW

The Fund's performance for the month was 0.10% in line with its benchmark return of 0.10%.

The money market rate for overnight is 1.55% per annum while the 1-month rate is between 1.70% to 1.75% per annum. The 3-month to 12-month rates are between 1.85% to 2.05% per annum.

BNM delivered another rate pause at its March 2022 MPC meeting, and the decision to keep OPR unchanged at a historical low of 1.75% was widely expected. The accompanied statement was by and large unchanged from the previous statement in January, save for the comments and assessment on Ukraine-related risks. The statement remained overall neutral, suggesting there is no immediate plan for any rate hike.

As the Fund's focus is on liquidity, we will continue to invest in money market placements and extend the placement duration for yield enhancement.

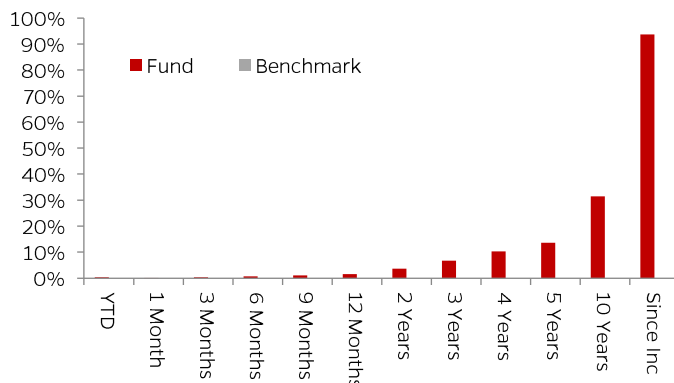

Based on the Fund's portfolio returns as at **10 March 2022**, the Volatility Factor (VF) for this Fund is **0.23** and is classified as "**Very Low**". The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified Funds. VF is subject to monthly revision and VC will be revised every six months.
