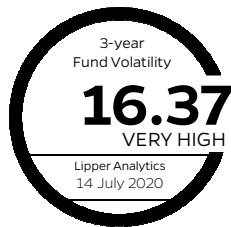

FUND MANAGER'S REVIEW

The FBM Emas Shariah Index was up by 11.63% in July as the local stock market rose significantly in tandem with positive market sentiment driven by local institution and retail investor buying interest on Bursa Malaysia. The fund's performance had increased by 10.63% and outperformed its benchmark by 3.58% during the period under review as the Fund's holdings on mid-cap and technology-related stocks had performed better than index stocks.

Overall, the Fund intends to keep its equity exposure at around 60% to stay invested in the current market condition with exposure tilting towards large and mid-cap stocks with positive earnings outlook that should benefit from post covid-19 economic reopening scenario.

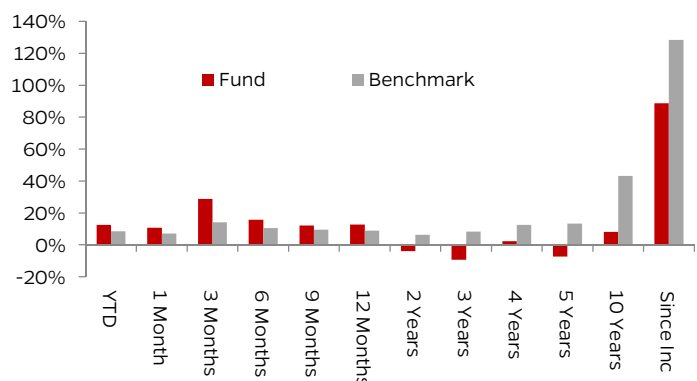

Based on the Fund's portfolio returns as at **14 July 2020**, the Volatility Factor (VF) for this Fund is **16.37** and is classified as **"Very High"**. The VF means there is a possibility for the Fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified Funds. VF is subject to monthly revision and VC will be revised every six months. The Fund's portfolio may have changed since this date and there is no guarantee that the Fund will continue to have the same VF or VC in the future. Presently, only Funds launched in the market for at least 36 months will display the VF and its VC.
