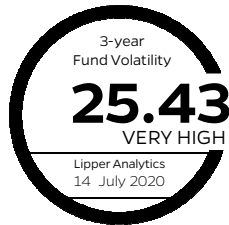

FUND MANAGER'S REVIEW

The FBMS Index was up by 11.63% in July as the local stock market rose significantly in tandem with positive market sentiment driven by local institution and retail investor buying interest on Bursa Malaysia. The Fund's NAV had increased by 28.28% on a 1 month basis as compared to its benchmark (50% of FBM Emas Shariah + 50% of 12 month Bank Islam TDT-i) return of 5.91%, thereby outperforming the benchmark by 22.37% during the period under review due to better performance of its stock mix and holding in the healthcare, Consumer and Technology sector.

In view of the current market situation, GDP growth outlook remains challenging for most countries as the Covid-19 Pandemic continues to spread across the Globe while countries such as Australia, China, Japan and Vietnam is facing a resurgence of outbreak in their country post opening of their local economy. The Fund intends to maintain its equity weight at around 90% - 98% range to stay invested in the equity market.

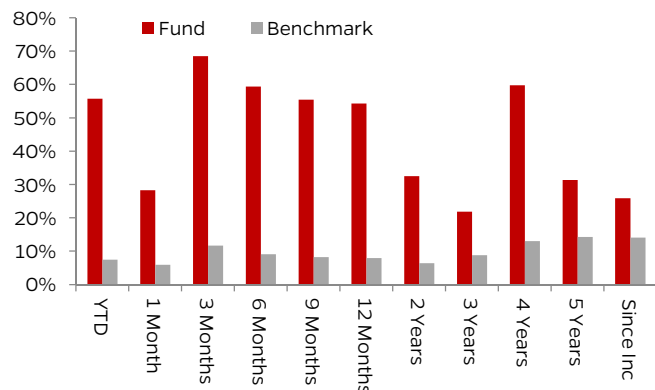

Based on the Fund's portfolio returns as at **14 July 2020**, the Volatility Factor (VF) for this Fund is **25.43** and is classified as **"Very High"**. The VF means there is a possibility for the Fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified Funds. VF is subject to monthly revision and VC will be revised every six months. The Fund's portfolio may have changed since this date and there is no guarantee that the Fund will continue to have the same VF or VC in the future. Presently, only Funds launched in the market for at least 36 months will display the VF and its VC.
