### FUND MANAGER'S REVIEW

The FBMS Index was up by 3.57% as the sharp rally on Dow Jones Index and post GE-15 election relief rally had boosted the market performance on Bursa Malaysia. The Fund's NAV had increased by 1.55% on month-on-month basis but underperformed its benchmark by 0.68% due to weaker performance of its investment holdings in growth-oriented stocks particularly Dnex as the company is having some issues with Chinese counterpart in terms of funding options for its new wafer plant in Malaysia.

Meanwhile, Malaysia's GDP performance continue to show encouraging performance with 3Q 2022 GDP growth registering an astonishing 14.2% YoY growth benefiting from the full re-opening of its economy since April. Overall, the Fund will maintain its investments in growth-oriented stocks to position for better NAV recovery as technology stocks in Malaysia is set to benefit from global semiconductor growth in the EV and smart devices segment. As China prepares to move away from harsh zero Covid policy in the future, the Fund's holdings in semiconductor-related stocks should benefit as the Android phone market in China is expected to rebound strongly post of that soonest by 1Q 2023.

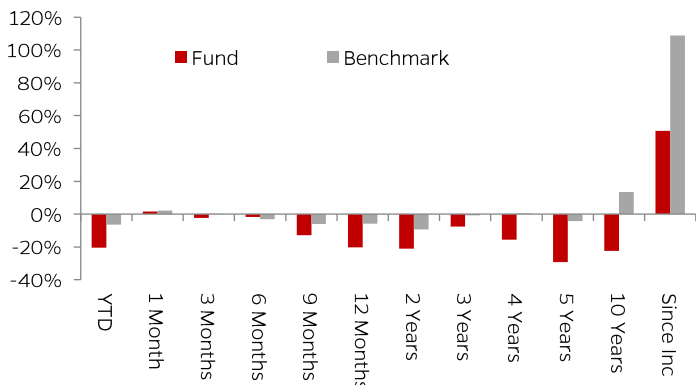

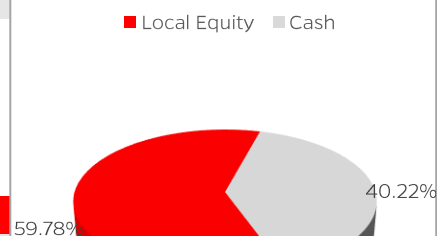
