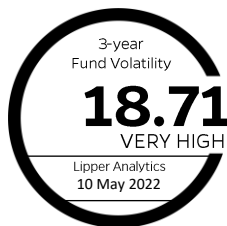


BIMB *i*-TACTICAL FUND



FUND MANAGER'S REVIEW

The FBMS Index was down by 4.26% due to the decline mainly in plantation and healthcare sectors as well as Axiata Group Bhd which posted weaker results in May. The fund's performance had decreased by 7.04% on 1-month basis partly due to its SP Setia holding suffered a sell down in the market along with other small and mid cap stocks.

On the local front, the full re-opening of Malaysia's border to all foreign tourist will benefit the fund's holdings in consumer related companies due to higher tourists spending. Therefore the fund will continue to invest in growth stocks to position for potential upside in the medium-term horizon particularly upon US Fed interest rate hike exercise nearing its tail end in 2023. Growth prospects of the fund remain sound with its stock mix expected to benefit from 5G and electric car market growth in the future. Tactically the fund had also invested around 5% weight in global technology companies to position for post US Fed rate hike upside potential while swapping SP Setia with other consumer-related growth stocks in the near term.

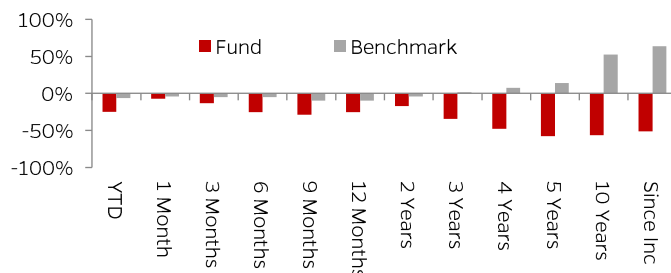

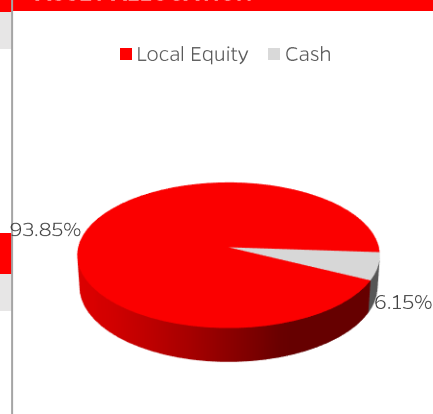

Based on the Fund's portfolio returns as at **10 May 2022**, the Volatility Factor (VF) for this Fund is **18.71** and is classified as **"Very High"**.
