FUND MANAGER'S REVIEW

The FBMS Index was up by 4.74% in February driven by Index linked plantation stocks as the sudden invasion of Ukraine by Russia had sparked a strong rally in CPO price surging to above RM6000/t due to supply disruption in global vegetable oil as well as rallies on other commodity products. The fund's performance had decreased by 2.04% on 1-month basis as technology stocks continued to face downward pressure due to investor's flight to safety.

Overall, the Fund intends to maintain its exposure in the global solar power and electric car supply chain to participate in these two industries while higher CPO price is expected to benefit the fund's holdings in property stocks as bumper income from smallholders often translates into better spending power among rural areas in the immediate term. Over the long run, we expect NAV price to rebound strongly once the sell-down on technology sector have subsides, much of which hinge on the war developments and Fed's interest rate hike movement. We will adjust the fund's stock mix from time to time depending on the situation with continued focus on companies with solid earnings to position for market recovery play by 2Q at the soonest.

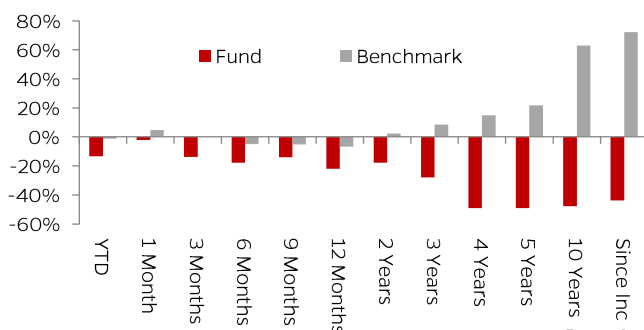

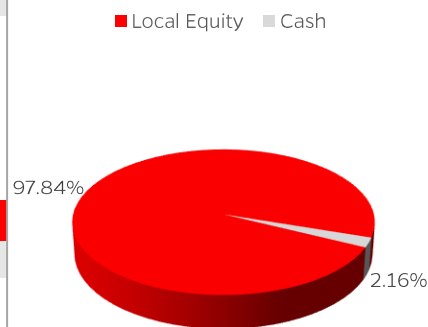
