FUND MANAGER'S REVIEW

The FBMS Index was up by 0.66% driven by rebound in plantation stocks as market was caught by surprise from Indonesia's sudden export ban of CPO products resulting in CPO price surging again. The fund's performance had on the other hand decreased by 5.46% on 1-month basis as the fund's holdings in technology stocks suffered more sell down due to anticipation of more rate hike by US FED in 2H of 2022 which resulted in global sell off on technology stocks.

Meanwhile, Malaysia's full re-opening from 1 April onwards as well as allowing EPF member to withdraw RM10k for their own use is seen as a strong boost to the local economy and domestic spending. While the global financial markets continued to be negatively affected by the war and sanctions on Russia by the west, sentiment on Bursa remains uncertain due to the US Fed interest rate and the surprise 25bps OPR hike by BNM. The fund will therefore increase its weights in consumer related stocks to help cushion the downside risk in the Fund's NAV without sacrificing its long term growth potentials post US fed rate hike cycle.

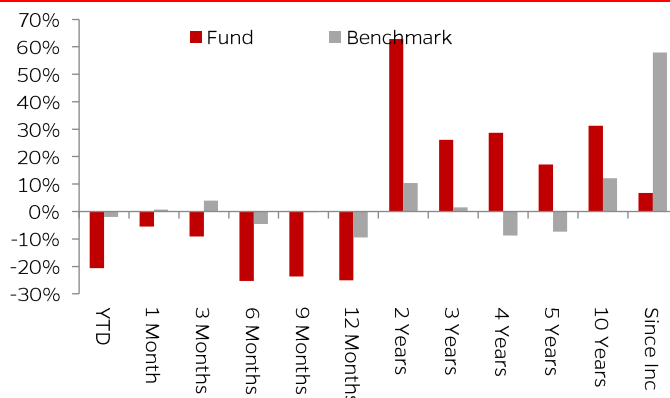

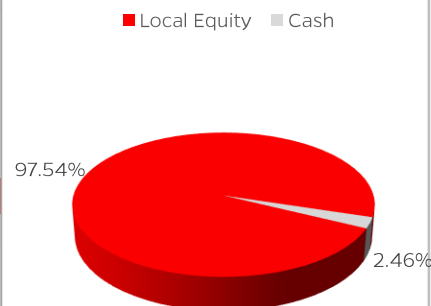
