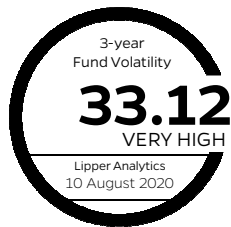

FUND MANAGER'S REVIEW

The FBMS Index was down by 2.03% in August as the local stock market declined due to profit taking activities on Bursa Malaysia. Nonetheless, the Fund's performance had increased by 5.58% on a 1 month basis and outperformed the benchmark by 7.61% during the same period under review due to better performance of its investment holdings during the month.

Moving forward, the fund will adapt a more defensive and responsive trading stance on its sector and stock mix to protect downside risk for the fund and strive to preserve the fund value, should market sentiment weakens further ahead of uncertainty surrounding US presidential election outcome in November as well as Covid-19 pandemic situation in Malaysia and abroad.

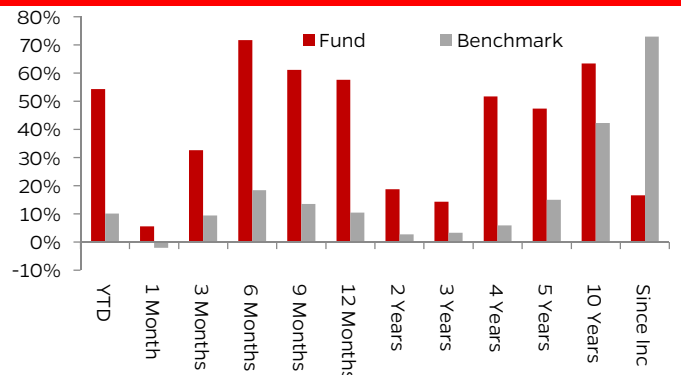

Based on the Fund's portfolio returns as at **10 August 2020**, the Volatility Factor (VF) for this Fund is **33.12** and is classified as "**Very High**". The VF means there is a possibility for the Fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified Funds. VF is subject to monthly revision and VC will be revised every six months. The Fund's portfolio may have changed since this date and there is no guarantee that the Fund will continue to have the same VF or VC in the future. Presently, only Funds launched in the market for at least 36 months will display the VF and its VC.
