

## BIMB ONE-YEAR SHARIAH INCOME FUND 3

### FUND MANAGER'S REVIEW

For the month under review, BIMB One-Year Shariah Income Fund 3 (Fund) registered a return of 0.56% as compared to its benchmark's return of 0.15%.

The Fund's outperformance was due to the returns generated from the notes that the Fund had invested.

As at 31 March 2022, the Fund has 43.75% exposure in Islamic Investment Notes and the rest in cash and cash equivalents.

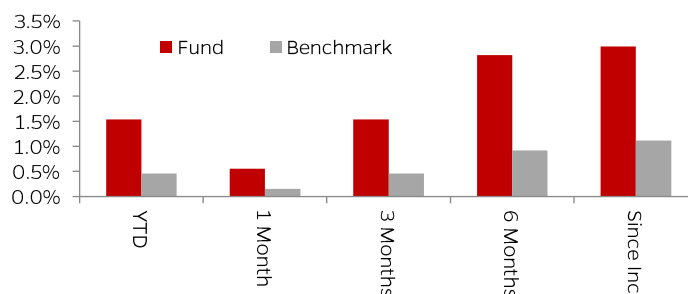

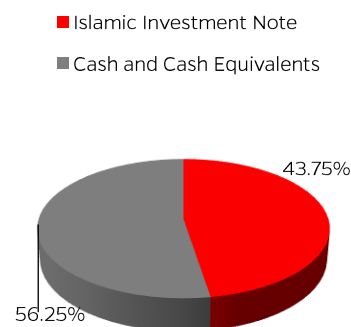
